REPORT TO DONORS – DECEMBER 2011

There are many reasons to celebrate the Christmas season; one of them is reading the letters from the recipients. It is clear that your generous donations have truly made a difference in the lives of these six young men and women. Whatever future they may have, we are helping them reach their goal of high school graduation.

We have also given them a message that there are people who care about them. I cannot imagine a better Christmas gift to them.

This year, we are providing financial support to six students from four different high schools. Since only one student is in Grade 12, it is becoming more important for me to plan ahead to ensure that the HOST Program can continue to provide its support through their remaining years of high school. I therefore ask you to seek out family members and friends who might wish to donate to help us assure our success. I have attached a Donor Form and an Information Sheet for your use.

I have also attached a financial statement for your review. Please let me know if you have any questions. You will note that I have already made the entire year's payment for one student. There was an issue with the student having sole access to the funds so the school created a locked-in trust account and I agreed to fund it in total immediately. Since the student has stated that our support will be used to pay for college tuition, the school's solution was in the student's best interests.

I have included excerpts from the six letters that I received from the recipients. I hope that they adequately convey their immense gratitude to you.

1. It became necessary to pay the entire year's award into a special school account to protect the recipient's interests.
 2. At the request of the school, a one-time assistance was provided to a student in need.
 3. If a donation is designated for a specific school, the amount is recorded as "Restricted for" that school. Otherwise, all donations are recorded as "Unrestricted Reserve".

HOST PROGRAM (Help Our Students)



A new Program that offers financial support to hard-working high school students in difficult financial circumstances.

The **HOST** Program provides ten monthly payments of one hundred dollars (\$100), from September through June, for a total of one thousand dollars per year. The criteria for selecting the students are:

- Student must have completed the first year of high school and must have demonstrated a high degree of commitment to school, a strong work ethic and dedication towards his/her academic program.
- Student must be in a difficult financial situation where financial assistance will have a significant impact on the student's quality of life.

Some important points:

- All donations are made directly through the participating schools. Since the School Boards are registered charitable organizations, they will issue a receipt for income tax purposes.
- Donations are deposited into a Trust Account at the Convent Glen Branch of the Royal Bank.

Donations may be earmarked for one specific school. Otherwise, the funds will be used as needed for students of any of the participating schools.

I am a retired federal public servant. My role as the HOST Program representative is to assist the schools in managing the Program, to solicit donations and to report back to all donors. I am doing this as a volunteer and 100% of all donations are given to the students. I cover all administrative costs.

When I was seventeen years old, I had decided to leave university for a number of reasons, including financial difficulties. A \$100 gift persuaded me to stay. I graduated, had a successful career and raised a wonderful family. I believe that the gift was a pivotal moment in my life.

Many years ago, my family and some friends started a Christmas tradition of anonymously offering Shopping Centre gift certificates to three High School students. They were selected by the school staff and the selection criteria were simple: the students had to be in difficult financial circumstances and had to have demonstrated a serious commitment to their studies. Academic scores were not a factor in selecting the deserving students.

Based on the thank-you cards that we received, it is obvious that we made a meaningful impact in their lives. The current HOST Program offers financial support for deserving students for an entire school year.
